

Orange-Chapel Hill Connector Route

The **Orange-Chapel Hill Midday Connector** service connects major origins and destinations in Hillsborough, Chapel Hill, and Cedar Grove (northern Orange County) with hourly service provided in both the northbound (Chapel Hill-Hillsborough-Cedar Grove) and southbound (Cedar Grove-Hillsborough-Chapel Hill) directions.

**Must be ADA certified with OCPT or show valid certificate from another transit agency.*



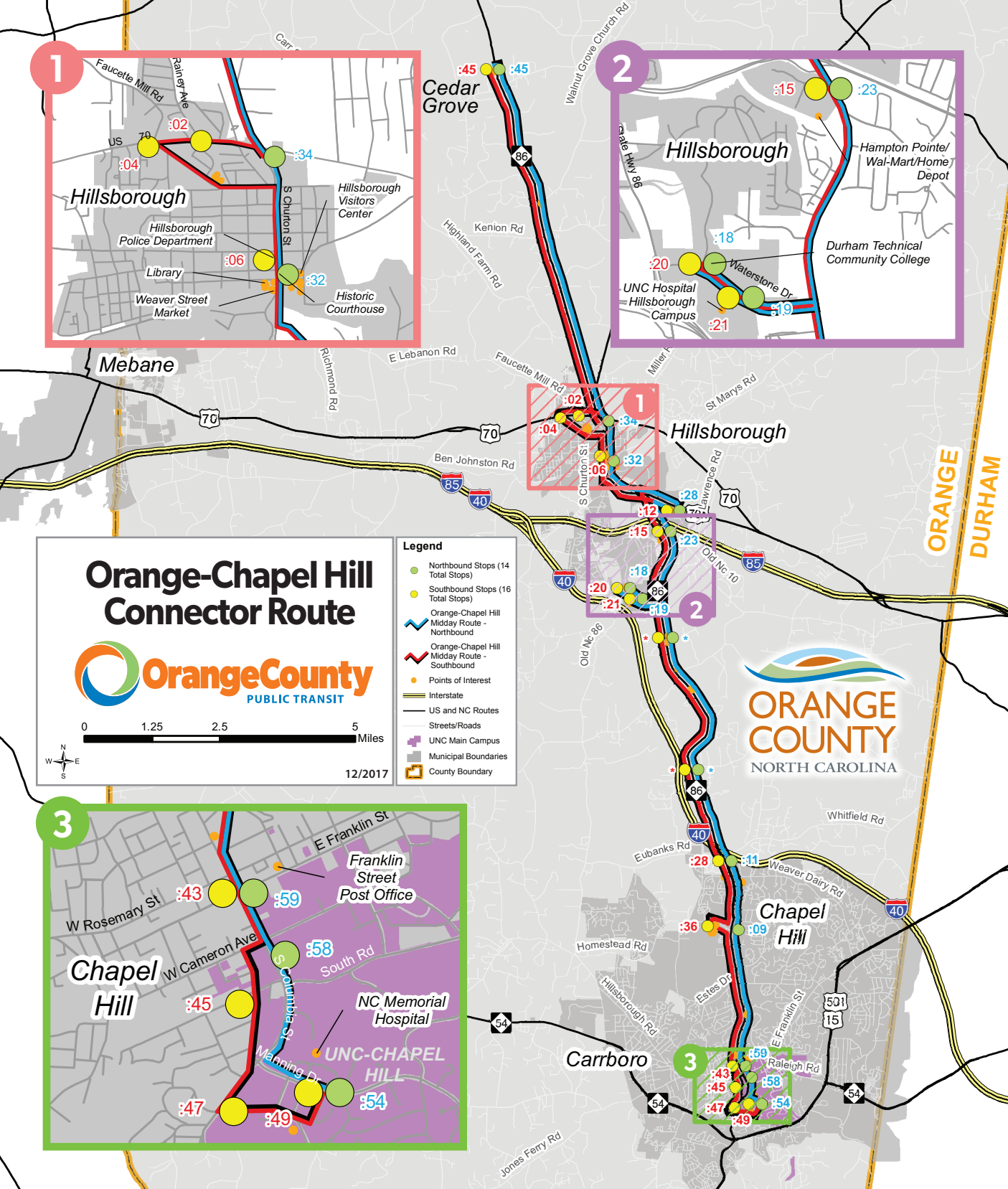

Guidelines for Riding the Bus

All OCPT buses are wheelchair accessible.

Arrive at the bus stop 5 minutes early. If your stop does not designate a timepoint, use the earlier time.

Raise your hand to signal you would like to board.

Tell the operator your destination.

Never cross in front of the bus, even when stopped. Never chase after the bus.
